Course Description

MCB 4XXX / MCB 6XXX is a 1 credit hour course that will be co-taught for undergraduate and graduate students. The course will cover various project management strategies and tools appropriate for innovation projects typical of life science research and development. Systematic approaches to establishing metrics and defining success criteria, as well as identifying risks and dealing with uncertainties will be discussed.

Course Pre-Requisites / Co-Requisites None.

Course Learning Objectives

This course will empower students with practical tools to manage innovation projects. They will develop an understanding of the different challenges and methodologies associated with each stage of project management. They will gain skills for setting objectives, developing and tracking progress, decision making, prioritization, and change management.

Undergraduate students will apply their learnings to a project report for a basic research project, academic goal, or extracurricular event. Graduate students will apply their learnings to a project report related to their literature review or thesis research.
